

# **UniBank Feel Good Banking Campaign Terms and Conditions**

## **Duration:**

The competition period commences at 9.00AM AEDT on 21 January 2019 and closes at 9.00PM AEST on 31 May 2019 (the "Competition Period").

## **Prizes:**

**Total Value of the prize pool is \$20,000**
